#### II. USE, SIZE AND PLACEMENT OF RESIDENCES AND STRUCTURES.

For Lots 1 through 5 single story homes shall contain no less than 2400 square feet and two story homes shall contain no less than 1400 square feet on the ground floor and a two floor total of no less than 2800 square feet.
